Exhibition dates: March 4 through March 23rd

Retrieval of Photos: March 24, 25 or 26th during gallery hours

How to Enter the Juried Show

1. Submit up to four images per entry
2. Entry fee is \$30 per entry (4 photos) by check payable to the BFAI. Additional entries will require an additional entry and \$30 fee.
3. Select paintings consistent to the theme "Every Picture Tells a Story". The theme is not inclusive or exclusive of any subject, technique or style. Photos shall not have been displayed during 2015 at the BFAI.
4. Send or deliver the completed submission form, entry fee and submitted images to the Beloit Fine Arts Incubator postmarked by February 9, 2016.
5. Submitted entries will not be returned unless a SASE is included. BFAI is not responsible for any damage during shipping.
6. BFAI will retain a 30% commission on all sales made during the exhibition.

Submission for Jurying & Conditions of Entry

1. The judges decision will be final.
2. On the submission form, fully describe the dimensions of the framed photo and sale price.
3. Photographs for submission should be at least 5 x 7 inches. Digital image files must be submitted as JPEGs on a CD. Emailed images will not be accepted.
4. Each submitted photograph or JPEG image must be identified with the artist's name plus the title of the photo..
6. All accepted photos must be suitably framed with wire for hanging. The BFAI reserves the right to refuse any entry because it is deemed unsuitably framed.
7. Accepted work may not be withdrawn before the close of the exhibition.

Additionally: The purpose of this show is to exhibit photographic works that are a true-to-life representation of the subject matter. We want to see the world through your eyes and not the multitude of post processing software tools. Minor burning/dodging, color correction, exposure adjustment and cropping is acceptable. The photograph, in its entirety, must be a single work of original material taken by the contest entrant.
